Advantages

There is no booking fee with the reservation made via our portal www.bestplace.sk. All present discounts, price bonuses and other bonuses are listed in the price lists at the web page www.bestplace.sk and are available to the client.

Beginning of the stay and departure – Check-in and check-out

The stay begins on the given day after 14:00 hours and the accommodation facility should be left on the day of departure by 10:00 hours at the latest. The time difference is reserved for cleaning the room and preparing it for the next visitors. On special occasions it is possible to agreed different check-in and check-out times depending on individual agreement with the accommodation facility.

Accommodation Voucher

The voucher is sent by an e-mail or by a classical mail after the customer has paid the required sum of money for the booked stay. The voucher entitles client to use the booked services. The accommodation provider will not accommodate more people than are presented in the voucher.

Prices

The prices of stays and complementary services are presented in valid price lists of the travel agency CK Best Place. The prices for the hotel accommodation presented on our web page are the same as the own prices of the hotels.

Reservation of Stay or Complementary Services

The reservation can be performed on line, by means of a form right in the pages of our travel agency, by mail, or by telephone (Preliminary booking). After we verify the availability of the required capacities, we will send to the client the confirmation (Confirmation of reservation and payment of deposit).

Payment Conditions

After Confirmation of the reservation is usually required to pay an advance deposit of 50 % the total price by the deadline indicated in the Confirmation of reservation. If the advance is not paid, the reservation will be automatically canceled. There is no booking fee. Surcharge (remaining 50%) is paid upon arrival right to the accommodation facility.

Cancellation policy

The cancellation fee depends on the time between the moment of cancellation of the reservation and planned arrival – start of the stay. In the special term such as New Year's Eve special cancellation policy is applied.

Cancellation terms:

To cancel the stay, you are required to pay cancellation charges as follows:
